Studies fashion design at Hochschule für Künste, Bremen. After a difficult start, is recompensed for unusual draping and seaming techniques.

### 1994

Attends Central Saint Martins College of Art and Design (CSM) in London to study BA Fashion Design Womenswear. Final graduation collection is selected for press show.

### 2000

Graduates in MA Fashion Design at CSM with film Infinite Repetition, first fashion student to investigate film and performance. Honoured with distinction and press accolades follow: The Independent, British Vogue and i-D Magazine.

### 2000

Receives Deutsche Bank Pyramid Award. Consolidates practice and creates *White Sheet, Enfant Terrible and Growing Young,* exhibited in the Grey Area show at Institute of Contemporary Arts, London (ICA) during London Fashion Week.

#### 2001

Awarded Artsadmin bursary validating the burgeoning cross-genre of fashion, performance and visual art. Creates *Shadow Doubles*, presented for Fashion in Motion at the Victoria and Albert Museum. First solo show at 291 Gallery, London. Published in *Collision or Collusion: Fashion and Art* in *ArtReview*.
