You are being invited to participate in a research project titled:

Block Pattern adaptation for Greek female adolescents with Scoliosis of the Spine: An investigation into the feasibility of incorporating body shape asymmetry into Sizing Systems to improve garment fit'

In other words, you are being invited to participate in a research project aiming to create 'foundation patterns' (blocks) for fashionable clothing, suitable for individuals having distinctive spinal features, due to scoliosis.

It will be a great contribution to my research, if you finally decide to participate in this survey. Before, however, you decide to participate, it is important for you to understand why this research is being done and what it will involve. Therefore, it would be wise for you to take your time reading the information below, carefully, and discuss it with others if you wish. Please feel free to ask, if anything is unclear, or if you would like more information.

The **purpose of this project** is to obtain reliable data for designing 'foundation patterns' (blocks), based on measure charts of body measurements of individuals with distinctive spinal features, due to scoliosis. Therefore, body measurements of 75 individuals (females aged 16-22) with various degrees of spinal curvature should be taken, as accurately as possible, after thorough observation of their different severity curves.

These blocks may be constructed to fit the curves of adolescent girls' spines diagnosed with scoliosis. Furthermore, these pattern blocks may be graded in all sizes, in a metric system of sizing, just like the one used for grading conventional pattern blocks. The only difference will be that these innovative blocks may also be graded in drop sizes, conforming to the different degrees of the spinal curves due to scoliosis.

At this point, the researcher's work will involve exploring issues at the intersection of medicine, ergonomics and fashion, due to the mere fact that her designs' primary aim will be a combination of comfort and ideal outward appearance of the wearer.

You are chosen to take part in this project owing to the distinctive configuration of your spine and your non-standard body dimensions. Your **participation is voluntary** and you may discontinue your participation at any time. If you do decide to take part, you will be given this information sheet to keep and be asked to sign a consent form.

The researcher and her assistant will take your body measurements – especially, your upper torso and spine measurements - by body touch, while a professional orthopaedist will measure your scoliosis degrees by scoliometer, in the presence of a gatekeeper (parent or guardian) and a witness (chaperon or nursing staff), in compliance with a certain code of ethics, and under the professional supervision of orthopaedist Prof. Anastasios Christodoulou, Director of the Spine Department at G. Papanikolaou Hospital, in Thessaloniki, Greece. The whole procedure will take place at one time, and is estimated to last approximately 45-60 minutes. During that time, you will be asked to stay in your underwear and remain as still as possible.

In addition, you will be asked to complete a **questionnaire** regarding your own perception of body image in relation to conventional retail clothing and the concepts of body image, clothing and fashion, in general.

Finally, you will be asked to complete an **evaluation form**, and may be invited, later, in a **wearer trial**, at the end of the project.

There are **no risks or disadvantages** related to this study. On the contrary, after this research is completed, the researcher aims towards a future collaboration with clothing manufacturers. This means that you may be able to find clothes without having any balance problems between the right and left side, as you, probably, had had with standard garments until now.

Your opinion and body measurements will be included / published in the final outcome of this research project and may be used in future research. However, your involvement in this study, and particular data from this research (i.e. name and contact telephone number), will be code numbered and will remain **strictly confidential**. Your personal details will be anonymized and only the researchers involved in the study will have access to the data. The identifiable data will be stored on computer and kept in file, in case of possible use for future research, once the experimental program has been completed. The data will be shared only with the researcher's Academic Supervisors and may be monitored by the researcher's College Research Committee (CRC) and the 'University of the Arts London' Ethics Sub-Committee.
